

## **Jump Zone Waiver, Release, Assumption of Risk, and Indemnity Agreement**

In consideration of being permitted in to and participate in activities located at The Jump Zone, LLC (hereinafter "Jump Zone") premises. I hereby agree as follows:

By **signing this document**, I am forever waiving and releasing any and all claims I may now or later have against The Jump Zone, LLC (hereinafter "Jump Zone") related in any way to the use of its equipment and facilities, including claims of negligence, and on behalf of myself, my spouse, children/wards, my parents, heirs, assigns, personal representatives and estate, I hereby agree to fully and permanently release, waive and discharge Jump Zone, its agents, owners, members, shareholders, directors, partners, employees, suppliers, manufacturers, participants, affiliates, successors and assigns (collectively the "Released Parties") from any and all claims, liability, demands, or causes of action related in any way to my use of or presence in any real or personal property of Jump Zone or the other Released Parties, without regard to whether a claim already exists or may arise in the future. I understand that (a) Jump Zone makes its property available to customers for recreational use only, (b) that using the property is purely a volunteer recreational activity designed for fun and is not necessary or required of me in any sense, (c) that I am assuming the risks set forth in this Agreement, and (d) if I am signing this Agreement to allow a minor child use the equipment, that I am representing and warranting that I have the legal ability to sign this form on their behalf and have medical insurance and the ability to pay for and indemnify Jump Zone from any and all bills, losses, liabilities, claims, obligations, costs, damages or expenses that may result from such minor's use of Jump Zone's property.

**Assumption of Risk-** I acknowledge and understand that the use of trampoline equipment is a recreational activity that involves risk of injury and may result in serious injury, paralysis, death, or damage to property or third parties. Known risks may include, but are not limited to, falling off equipment, double bouncing, collision with fixed objects and/or people, and failed attempted jumps and stunts. I understand that jumping on trampolines and other activities located at the premises of Jump Zone is inherently dangerous. Risks are also inherent in the use of a foam pit. Jump Zone employees cannot and will not eliminate the risks of jumping on a trampoline or otherwise using the equipment with others. I understand that if I do not want to take these risks then I should NOT sign this document or use the equipment or participate in these activities. In spite of the risks mentioned above, I freely want to participate and as such I assume all responsibility of injury, damage or even death that may result.

**Release of Liability-** I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Released Parties from any and all claims, demands, or causes of action, which are in any way connected with or related to my participation in any Jump Zone activities or my use of any equipment or facilities owned or operated by the Released Parties, including without limitation Jump Zone I am assuming on behalf of myself and/or Minor child, all risk of personal injury, death, or disability to myself and/or the minor child that may result from participation or use of Jump Zone facilities.

**Warranty and Indemnification-** I represent, warrant, and certify that (1) I have adequate medical or other insurance to cover and pay for any possible injury that may occur to me or the minor child for whom I have signed this Agreement, including without limitation any
